Maximize Your Savings with CU SoCal

CU SoCal is committed to helping you build a strong financial foundation by offering a range of savings options that not only keep your money safe, but also help it grow. Whether you're saving for a major purchase, planning for retirement, or just looking to build an emergency fund, our accounts are designed to meet your needs and ensure you're prepared for whatever the future holds.



Money Market Accounts. These accounts allow you to earn higher interest rates than traditional savings accounts. The deposit minimum starts at \$2,500.

Seasonal Savings Accounts. Save for holiday expenses or summer activities with our seasonal savings accounts. Earn higher dividends than a Share Savings Account and enjoy penalty-free withdrawals during specific times of the year.

Dear CU SoCal,

What is the "Care to Share" referral program, and how can I benefit from it?

Dear Curious:

"Care to Share" is CU SoCal's way of saying "thank you" for spreading the word about our credit union. It's a referral program that rewards you when you introduce new Members to CU SoCal. Not only do you help your friends and family access affordable credit and financial services, you also can earn up to \$50* for your efforts!

Ask CU SoCal

Here's how it works:

- Earn \$25. When your referral opens a Membership along with a Classic or Rewards Checking Account with a \$100 minimum opening deposit, you'll receive \$25.
- Earn \$25 more. Your earnings don't stop there! If your referral establishes a monthly direct deposit of at least \$750 within 90 days of opening their account, you'll earn another \$25. This means you can earn a total of \$50 just for referring a new Member who meets the criteria.

The referral process is quick and easy. Here's what you need to do:

1. Refer a Friend. Visit CUSoCal.org/CareToShare and invite a friend or family member via email to join CU SoCal by opening a qualifying checking account with direct deposit.

- 2. Share Your Info. When sending the email invitation, make sure your name and address are included. Your friend will need this information when they open their account.
- **3. Receive Your Bonus.** Once the new account is active and meets the necessary requirements, you and your friend will receive your \$25 cash bonuses.

All new accounts will be verified by ChexSystems® and are subject to approval and Membership eligibility. Both referred and referring Member will receive a \$25 cash bonus when referred Member opens a qualified checking account with the required minimum deposit of \$100 at account opening. Qualified checking accounts are defined as Rewards Checking and Classic Checking. Both referred and referring Member will receive an additional \$25 cash bonus when the referred Member encives a minimum monthly direct deposit of \$750 within 90 days from establishing Membership. Referred Member may earn another \$25 for funding an auto or personal loan within 90 days of establishing Membership for up to \$75 total. Maximum cash bonus referrer can earn is up to \$50. Cash bonuses will be credited to Member's CU SoCal deposit account within 60 days from the date the referred Member meets the requirements. Offer cannot be combined with other promotional offers. Cash bonus may be subject to tax reporting.

Board and Supervisory Committee Nominations

Three Board Members and two Supervisory Committee Members are up for election in 2025. Elizabeth Camp, Paul Moore, and Dawnna Lawrence have each been nominated to serve three-year terms on the Board of Directors. Rosie Robinson and Bob Toohey have each been nominated to serve two-year terms on the Supervisory Committee.

The Nominating Committee has determined that these volunteers are qualified and have the necessary experience to serve our Membership. As a CU SoCal Member 18 years or older and in good standing, you are eligible to run for an elected position. Petitions for nominations of candidates for these positions will also be accepted. Petitions must be submitted by Friday, January 10, 2025, to the secretary of the credit union. A valid petition must have at least 500 signatures from CU SoCal Members, be accompanied by a signed "Willingness to Serve" statement, a signed "Code of Ethics/Statement of Consent," and a statement (not to exceed 250 words) detailing the candidate's gualifications for office and reasons for candidacy. Petition packages are available upon request from the Member Care Center at 866.287.6225, Monday through Friday 9 a.m. to 6 p.m., and Saturday 9 a.m. to 1 p.m.
